SAFETY

SWANA continues its strategic focus on promoting safety and reducing the injury and fatality rates in our industry. However we continue to read in the news about injuries and fatalities that occur in our industry. From the death of a helper placing track in the back of a truck to car – truck collisions, there are too many accidents that could possibly be avoided. The first defense is training our employees to be ever vigilant in their daily routines and to expect the unexpected when out on routes, depositing materials at receiving facilities, or properly managing the waste at

landfills. In addition, as an industry we need to continue to push the legislators and rule makers to put into place legislation that focuses on the industry and making is safer for our employees to perform their essential duties. Over the years SWANA has been pivotal in getting over thirty states to enact some type of "Slow Down to Get Around" laws to help protect solid waste workers out on the job. While CT expanded their law in 2023 to include non-emergency vehicles that are stationary, it did not go far enough to include those vehicles moving at slow speeds and performing their jobs. It is imperative that we as an industry continue to push for expanded laws to protect our workers.

SWANA NEWS

On August 6th, SWANA HQ held a Chapter Chat with Amy Lestition Burke, SWANA's Executive Director / CEO to review the initial results of the survey of the SWANA members. This discussion centered around what our members are looking for from SWANA, both nationally and from the local chapters, and how we can chart our path forward.
